

As construction continues on the I-10 Express Lanes project, work in the City of Ontario will generally occur Monday through Friday during daytime (6:00 a.m. to 4:00 p.m.) and nighttime (9:00 p.m. to 5:00 a.m.) hours, except as noted below. Please remember, all construction is dynamic and the schedule is subject to change.

Bridge Demolition and Construction

Eighteen bridges throughout the corridor will either be replaced, widened, or improved to accommodate the widening of the freeway. During times of demolition, shoring, and backfilling work will be loud and vibration will occur. You will see bright lights and hear equipment including excavators, backhoes, loaders, and dump trucks. Upcoming bridge activities in Ontario include:

- **Vineyard Avenue:** Vineyard Avenue over I-10 will be widened in two phases. Daytime and nighttime activity includes drainage work and building temporary supports.
 - On February 19 from 9:00 p.m. to February 22 at 5:00 a.m. Vineyard Avenue will close between G Street and Inland Empire Boulevard. Detour routes will be posted and include Inland Empire Boulevard, Archibald Avenue, and G Street. Businesses will remain open and accessible. Eastbound (EB) and westbound (WB) on- and off-ramps at Vineyard Avenue will be intermittently closed nightly and will be limited to right-turns only during the day. Vineyard Avenue partial bridge demolition is tentatively scheduled for March 5 and 6. More information will be provided.
- **4th Street:** Crews continue to relocate underground utilities at 4th Street and are preparing to build a new wider section of the EB side of the freeway. 4th Street between El Dorado Avenue and Vineyard Avenue is reduced to one lane and there may be delays during morning and evening hours. Daytime and nighttime activities include excavation near the end of the support structures of the bridge and drainage installation. Work on 4th Street began in spring 2020 and will last for approximately two years.
- **Grove Avenue:** A portion of the EB and WB I-10 shoulder over Grove Avenue was removed in December 2020. Crews will continue to prepare the existing bridge for widening. Daytime and nighttime activities include shoring (building temporary support structures) and sawing and removing pavement. Work is expected to be complete in approximately nine months.
- **Sultana Avenue:** Crews continue to build the new Sultana Avenue bridge over I-10. The new bridge is anticipated to open in March 2021. Daytime and nighttime activity includes constructing the bridge deck.
- **Euclid Avenue:** Crews continue to rebuild the new wider portion of the eastside of the Euclid Avenue bridge. Daytime and nighttime activities include bridge construction and removal of temporary support structures. Work on Euclid Avenue began in mid-May 2020 and will last for approximately 18 months.

- **Benson Avenue:** A portion of the EB I-10 shoulder over Benson Avenue was removed in early-December 2020. Benson Avenue between 5th Street and Moreno Street will have reduced lanes with flaggers directing traffic during daytime hours through February 19. Crews will be shoring (building temporary support structures), sawing, and removing pavement. Bridge widening work will continue for approximately two years.
- **Mountain Avenue:** In November 2020, crews removed a portion of the EB I-10 shoulder over Mountain Avenue. Daytime and nighttime activities include pouring concrete and placing rebar. Work began in fall 2020 and will last for approximately 18 months.

Retaining and Sound Wall Work:

Crews will continue to demolish retaining walls and sound walls at several locations near the EB lanes of I-10 between Mountain Avenue and Vineyard Avenue. This work will be loud and vibration will occur. Equipment used includes excavators, backhoes, loaders, and dump trucks.

Retaining walls and sound walls are located on State property next to the freeway. K-rail is placed on the freeway shoulders and crews work between the k-rail and wall locations. Once walls are demolished, materials are removed so crews can prepare the land for the replacement wall.

Local Street Closures:

Crews are removing sound walls and retaining walls, relocating utilities, and removing trees on several local streets adjacent to the I-10; at times this work may be loud and you may feel vibration. One side of the sidewalk will always remain open.

- Daytime and/or nighttime lane closures, streets will remain open:
 - Benson Avenue, Mountain Avenue, San Antonio Avenue, Euclid Avenue, Alvarado Street, Campus Avenue, 6th Street, 4th Street, Vineyard Avenue and Milliken Avenue
- Nighttime street closures, detour routes will be posted:
 - Mountain Avenue: NB/SB street intermittently closed under I-10
 - Grove Avenue: Northbound (NB)/southbound (SB) street intermittently closed under I-10
 - 4th Street: WB lanes street closed nightly under I-10

Local Ramp Closures:

Intermittent nighttime EB and WB on- and off-ramp closures, detour routes will be posted:

- Mountain Avenue
- Euclid Avenue
- 4th Street
- Vineyard Avenue
- Holt Boulevard
- Milliken Avenue
- Haven Avenue
