

As construction continues on the I-10 Express Lanes project, work in the City of Ontario will generally occur Monday through Friday during daytime (6:00 a.m. to 4:00 p.m.) and nighttime (9:00 p.m. to 5:00 a.m.) hours, except as noted below. Please remember, all construction is dynamic and the schedule is subject to change.

**Reminder: Tonight May 21 through May 24
Northbound I-15 to Westbound I-10 55-hour Freeway-to-Freeway Connector Closure**

The northbound (NB) I-15 to westbound (WB) I-10 connector will be closed on Friday, May 21 at 10:00 p.m. through Monday, May 24 at 5:00 a.m. Up to two lanes of WB I-10 from the I-15 to Milliken Avenue will also be closed. Motorists should plan ahead, leave early, follow posted detour routes, and allow extra time to reach their destination.

Detour: NB I-15, exit 4th Street, turn right on to 4th Street, turn right to access southbound (SB) I-15 on-ramp, keep right to access WB I-10.

Bridge Demolition and Construction

Eighteen bridges throughout the corridor will either be replaced, widened, or improved to accommodate the widening of the freeway. During times of demolition, shoring, and backfilling work will be loud and vibration will occur. You will see bright lights and hear equipment including excavators, backhoes, loaders, and dump trucks. Upcoming bridge activities in Ontario include:

- **Benson Avenue:** A portion of the eastbound (EB) I-10 shoulder over Benson Avenue was removed in early-December 2020. Bridge widening work will continue for approximately two years. Benson Avenue under I-10 will be closed weekdays during nighttime hours for installation of temporary frames and installing k-rail.
- **Mountain Avenue:** In November 2020, crews removed a portion of the EB I-10 shoulder over Mountain Avenue. Work began in fall 2020 and will last for approximately 18 months. Daytime and nighttime activities include building support structures and backfilling supports with dirt.
- **San Antonio Avenue:** Crews are continuing to relocate utilities on San Antonio Avenue and preparing the bridge for demolition, anticipated in late 2021. Work is occurring during daytime and nighttime hours. San Antonio Avenue may be intermittently closed during nighttime hours with flaggers directing traffic.
- **Euclid Avenue:** Crews demolished the east side of the bridge and are working on rebuilding the NB lanes. Work on Euclid Avenue began in mid-May 2020 and will last for approximately 18 months. Daytime and nighttime activities include rebuilding local streets and installing utilities and casings.
- **Sultana Avenue:** Crews continue to build the new Sultana Avenue bridge over I-10. The new bridge is anticipated to open in June 2021. Daytime and nighttime activities include building slabs that connect the bridge to the street and installing brackets on the bridge.

- **Campus Avenue:** This summer, Campus Avenue over I-10 will be closed to prepare for demolition. Once the original bridge is demolished, crews will rebuild the bridge to accommodate the additional lanes on the I-10. To prepare for this work, utility relocation is occurring between Richland Street and 6th Street during daytime and nighttime hours.
- **6th Street:** Anticipated to occur in June 2021, 6th Street over I-10 will be closed to allow crews to prepare for demolition. Once the original bridge is demolished, crews will rebuild the bridge to accommodate the additional lanes on the I-10. Utility relocation is occurring between Campus Avenue and Holmes Court during daytime and nighttime hours.
- **Grove Avenue:** A portion of the EB and WB I-10 shoulder over Grove Avenue was removed in December 2020. Work is expected to be complete in fall 2021. Crews continue to widen the existing bridge. Grove Avenue under I-10 will be intermittently closed to through traffic and detour routes will be posted. Daytime and nighttime activities include excavating and removing lower portions of the support structures.
- **4th Street:** Crews continue to relocate underground utilities at 4th Street and are building a new wider section of the EB side of the freeway. Work on 4th Street began in spring 2020 and will last for approximately two years. 4th Street between El Dorado Avenue and Vineyard Avenue is reduced to one lane during daytime hours. 4th Street under I-10 will be intermittently closed during nighttime hours. Detour routes will be posted. Daytime and nighttime activities include forming and pouring bridge supports and utility relocation.
- **Vineyard Avenue:** The east side of Vineyard Avenue over I-10 was partially demolished in early-March. Construction will last approximately 18 months. Vineyard Avenue over I-10 may have reduced lanes during daytime hours and may be intermittently closed during nighttime hours. Continuing daytime and nighttime activities include installing beams into the ground and placing forms and rebar on the top portion of the bridge.

Retaining and Sound Wall Work:

Crews will continue to demolish retaining walls and sound walls at several locations near the EB lanes of I-10 between Benson Avenue and Haven Avenue. This work will be loud and vibration will occur. Equipment used includes excavators, backhoes, loaders, and dump trucks.

Retaining walls and sound walls are located on State property next to the freeway. K-rail is placed on the freeway shoulders and crews work between the k-rail and wall locations. Once walls are demolished, materials are removed so crews can prepare the land for the replacement wall.

Local Street Closures:

Crews are removing sound walls and retaining walls, relocating utilities, and removing trees on several local streets adjacent to the I-10; at times this work may be loud and you may feel vibration. One side of the sidewalk will always remain open.

- Daytime and/or nighttime lane closures, streets will remain open:
 - Mountain Avenue, San Antonio Avenue, Euclid Avenue, Alvarado Street, Campus Avenue, 6th Street, 4th Street, Vineyard Avenue, and Haven Avenue
- Nighttime street closures, detour routes will be posted:
 - Benson Avenue: NB/southbound (SB) closed under I-10
 - San Antonio Avenue: NB/SB street closed to through traffic, residential access remains open
 - Grove Avenue: SB/NB street intermittently closed under I-10
 - 4th Street: EB/WB street intermittently closed under I-10
 - Vineyard Avenue: NB/SB street intermittently closed over I-10

Local Ramp Closures:

The WB Haven Avenue on-ramp will be closed for ten days to repave and realign the on-ramp. Work will continue through Thursday, May 27 at 5:00 a.m. Detour route: To access WB I-10, continue south on Haven Avenue, right on to Guasti Road, right on to Archibald Avenue, and keep left to access WB I-10.
