workers. While many area companies

previously allowed employees to work at home, the vast majority of telework programs tended to be informal and on an as-needed basis. Fewer than 6% of employees in Southern California previously worked offsite on a regular or full-time basis.

As restrictions are being lifted and employees starting to return to the office, it is still not business as usual—and may never again be.

In one study of 300 employers in Orange County conducted in July, more than half of those surveyed plan to continue allowing employees to work from home when restrictions on gathering in offices are lifted.

Adds the Association for Commuter Transportation in a guide to help employers manage their commute programs during the pandemic, "As organizations look to re-open their worksites, many plan to continue allowing employees to work from home permanently or part time to reduce onsite numbers to support physical distancing."

We got a peek at how traffic and air quality *could* improve.

Fewer cars and trucks on the road as people stayed home meant fewer



emissions being spewed into the air.

Shortly after the Order got underway, the South Coast Air Quality Management District (AQMD) reported slightly

> improved air quality (though that was due to favorable weather as well as car traffic dropping by about a third).

Bus and rail made major adjustments in safety and scheduling.

Local transit agencies stepped up efforts to provide a safe environment for riders and transit

workers and continue to do so.

This includes a mix of increasing cleaning protocol, providing hand sanitizing stations, providing masks to



riders, switching to rear-door boarding to limit contact between riders and drivers, among other efforts to reduce the spread of the airborne virus.

At Metrolink, additional train cars have been added on the busier lines to better allow for social distancing

among riders. Some bus providers are doing the same—running two buses in quick succession so if the first bus seems too full, it's a short wait for the second bus.

With fewer people riding overall due to the pandemic, transit agencies have also had to adjust schedules—temporarily



eliminating underutilized routes or rerouting where necessary.

Most transit agencies' schedules are still not at their pre-COVID rates, so you can help employees find their best current route by telling them to call 511. They can also get 24/7 help online at ridematch.info (Los Angeles/Orange/Ventura counties) or at IECommuter.org (Riverside/San Bernardino counties).

Transit agency changes due to COVID-19 are also updated daily on weekdays at **go511.com**.

And an unexpected bright side: Road and freeway construction moved ahead of schedule.

The emptier streets and freeways allowed agencies to speed up roadwork schedules on major projects through the Southland in 2020. That progress is expected to continue in 2021 on projects ranging from rail tunneling to major improvements on the I-405 to streetcar construction and more.

As an ETC, your help through this crisis has been—and will continue to be—vital.

Thank you to all the Southern California ETCs who have risen to the occasion to help commuters through this unprecedented time.

You have helped employees manage new telework schedules, find alternatives to their usual route and—in many cases—changed entirely how you handle rideshare incentives and programs to meet new challenges.

as part of their benefits for employees," says Justine Sobczyk with **Benefit Resource, Inc.,** a pre-tax commuter benefit administrator. "If they own a

parking garage and parking facility, or if they lease parking, it could be potentially thousands of dollars that they were writing off that they can't any longer."

The same is true for qualifying transit and vanpool costs, though for most companies

those overall are typically less than that of parking.

For this first year under the new tax law, employers may not feel the sting as much due to the Coronavirus pandemic since they may not have been paying for as many commute costs as they normally would.

"Right now, we're not seeing a whole lot of utilization of commuter transportation because of COVID and more people working at home," says Sobczyk. "But as we start to open back up and get back to a usual state of commuting, that will change."

The same goes for employees working at home who haven't been receiving subsidized commute costs.

What isn't part of the tax changes: Employees who pay for qualifying transit, parking and vanpool expenses (up to \$270 per month) with their own money using pre-tax dollars. This remains an allowable benefit under Internal Revenue Code Section 132(f) that can lower an employees' overall taxable income, saving them money.

Will employers be less willing to promote transit and vanpooling if it's no longer tax deductible?

For ETCs tasked with promoting alternatives to driving alone, the loss of tax

write-offs for transit and vanpooling raises the question, Does this mean employers will be less likely to subsidize these options in the future? Will that remove the incentive for commuters to use them?

The answer is: nobody knows for sure. In some areas, especially in large

metropolitan areas like Los Angeles—local ordinances that require employers to offer a commuter benefit, both current and in the works, may start to see more adoption of pretax benefits, suggests Sobczyk.

There is also the possibility that the tax

law may be revised, or that the overall impact on a corporation's overall budget will be negligible and therefore won't negatively impact the rideshare program.

Metro Micro Expands to New Service Zones



Metro Micro recently expanded into three new zones in Compton/Artesia, El Monte and North Hollywood.

Metro Micro is L.A. Metro's new ridehailing service that offers shared rides, operating within certain zones. Rides cost an introductory rate of \$1 per ride (transfer not included) for the first six months.

Metro Micro is designed to replace short, solo trips by offering a flexible, ondemand service operated by Metro employees in vehicles that hold up to 10 passengers. Along with other safety measures, capacity is currently limited to five passengers to reduce risk during the COVID-19 pandemic.






What's Important to You in L.A. Metro Transit?

OC Streetcar Project Chugging Along

After nearly two years of construction, the OC Streetcar recently celebrated a milestone with the first rail being laid into place.

The OC Streetcar will be Orange County's first modern streetcar. When complete, it will run more than four miles in each direction—from the Santa Ana Regional Transportation Center to a new transit stop at Harbor Boulevard in Garden Grove.

In addition to serving major shopping, school and business destinations, it will connect to OC Bus, Amtrak and Metrolink.

OCTA held a **virtual open house** to educate the public about the project.

San Bernardino Commits to Health and Safety Pledge

Transit agencies in San Bernardino County have joined a national effort to commit to policies and practices that reduce health risks on transit during the Coronavirus pandemic.

The effort calls for transit agencies and riders to follow official public health guidelines as well as increased cleaning protocol on transit, enabling social distancing on buses, trains and at stations and requiring employees to stay home if they're sick or have been exposed to COVID-19—and asking riders to do the same.


Interested in Keeping Ventura County Moving?
