# Tackling the Problem of Illegal Cannabis Grows at a City and County Level



# Impact to City/County Operations

- Delays to Police and Code Enforcement resident service response
- Requires a multi-department response
- Consumes limited Building Inspection and Sanitation staff
- Post enforcement actions further strains limited Code Enforcement personnel
- Requires jurisdictions to use general funds to abate public nuisances generated from cannabis grows

## Code Enforcement Compliance Efforts

#### **Characteristics**


- Often located within residential housing tracts
- Rental properties
- Covered or painted windows
- Use of:
  - Bright interior lights
  - Multiple AC condenser units
  - ✓ Large air filters to reduce exterior odors
- Marijuana odors surround properties
- Plant waste approximately every 90-120 days
- Caretakers are often human trafficking victims



## Code Enforcement Compliance Efforts

#### Immediate Hazards & Common Violations


- Bypassed/overloaded electrical systems prone to fires
- Explosion hazards from honey oil operations (butane)
- Inhalation and skin hazards from fertilizer & pesticides
- Atmospheric hazards from high carbon dioxide levels
- Alteration/damage to various structural components
- Hazardous living conditions to cultivation caretakers/occupants
- Mold from excessive high humidity environments
- Structure modifications requiring extensive repair



## Code Enforcement Compliance Efforts

#### Enforcement, Fines & Investigation


- Occupant arrest for utilities theft
- Cannabis abatement by Police and City staff
- Citation and Illegal Cultivation field report issuance
- Recording of a Notice of Pendency
- Termination of impacted utilities
- Property owner fines:
  - \$100/plant Fine issued to the property owner
  - \$1,000/per day for uncorrected violations at 30th day
- Identification of other properties owned by listed property owners or business entities through county systems
- Use California Secretary of State corporate and LLC search



## Code Enforcement Compliance Efforts

#### **Staffing and Partnerships**

- Victorville Police enforcement reporting and actions/ abatement
- Building and Safety conducts structure damage assessments
- So-Cal Edison utility theft and electrical system load assessment
- City Water Department water contamination and utility disconnection
- Victorville Fire hazmat and fire response
- Victorville Sanitation transports and disposes of waste
- County Solid Waste Division expedites landfill access




## Victorville Enforcement Results

#### **Strengthened Enforcement Procedures**

- 85% cannabis grows reduction after adoption of \$100 per plant fine
- Efficient law enforcement coordination
- Improved officer safety response protocols
- Comprehensive reports and property owner investigation
- Court consideration of owner cannabis grow history
- Fines upheld by civil courts

## Administrative Enforcement Process and Legal Measures

- Appeal of the Administrative Citation
  Extend time for appeal
- Provide a Comprehensive Officer Report
  - Enforcement action summary
  - Property ownership and licensing records
  - Cannabis grow history
  - List all occupants present during the enforcement action

#### Superior Court Appeals

- Sustained per plant fines (8<sup>th</sup> amendment argument)
- Sustained fines to the property owner

#### City Attorney Case Settlement Coordination

- Timely cost recovery reimbursement
- Stipulations regarding timely property repairs
- Gov Code Section 53069.4
  - Review lease agreements for language prohibiting cannabis cultivations
  - Presence of the tenant listed in the lease agreement during the enforcement action



## OUTDOOR GROWS

## Code Enforcement Compliance Efforts

#### **Characteristics**

- Operate in rural areas
- Large in scale with non-permitted grading of raw or undisturbed lands
- Self-contained with dumping of sewage, waste and trash on site
- Consume massive amounts of water impacting water resource in the community
- Workers live on site in trailers, RV's, sheds, illegal structures
- Cause dust (traffic), odor (cannabis), noise (fans/generators) and nighttime light pollution





## OUTDOOR GROWS

## Code Enforcement Compliance Efforts

#### **Immediate Hazards & Common Violations**

- Large pits used for trash and trespassing deterrent
- Disposal of hazardous chemicals and Sewage waste
- Environmental and ecological damage
- Bypassed water meters, illegal wells and theft of electricity
- Armed criminal element
- Illegal structures
- Hazardous substandard living conditions
- Junk, trash, debris, and inoperable vehicles
- Unpermitted grading







## Code Enforcement Compliance Efforts

## **OUTDOOR GROWS**

#### Enforcement, Fines & Investigation

- Enhanced administrative citations (Civil prosecution)
- Penalties: admin/criminal citations
- Less than 200 plants: \$1000, \$1500, \$3000
- More than 200 plants: \$3000, \$6000, \$10,000
- Notice of Action/Liens clouding title
- Special assessments to recover costs
- Abatement actions to clear trash and debris
- Use of temporary restraining orders
- Use of receiverships



# Penalties and Fines

City/County	Sample: 1000 Plants	Per Plant Fine	Set Penalty/ Charge	Additional Fines	Total Agency Fines (Single day)
Victorville	1000	\$100 per plant	\$0	\$1,000 per day, per violation	\$100,000 +
San Bernardino County	1000	\$0	\$10,000	\$10,000 per day	\$10,000
State of California (Law Enforcement)	Unlimited	\$0	Misdemeanor Charge \$25-\$500 fine	\$0	\$500

## Code Enforcement Compliance Efforts

#### **Staffing and Partnerships**

- Dedicated Code Enforcement Cannabis Team: Supervisor, 3 Code Enforcement Officers (CEOs), and 1 Technician
- Dedicated Abatement Team: 2 CEOs
- One CEO assigned to each Sheriff Marijuana Enforcement Team
- Dedicated Deputy County Counsel
- Collaboration with:
  ✓ District Attorneys Office
  - ✓ Water boards
  - California Department of Fish and Wildlife




