





I-10/MT. VERNON AVENUE IMPROVEMENTS

Colton, CA

Overview

The San Bernardino County Transportation Authority (SBCTA), Caltrans, and the City of Colton have partnered to improve Mt. Vernon Avenue over Interstate 10 (I-10). Once constructed, the project will improve circulation during high demand hours along Mt. Vernon Avenue between East Valley Boulevard to the north and the I-10 eastbound ramps/Mt. Vernon Avenue intersection to the south. The anticipated start of construction is March 2026.

Project Benefits

- Reduce local traffic congestion along Mt. Vernon Avenue and East Valley Boulevard.
- Improve bicycle and pedestrian mobility along Mt. Vernon Avenue through the interchange.
- Provide Americans with Disabilities Act (ADA) compliant curb ramps, crossing activators, and tactile sensors at intersections where crosswalks are included.
- Construct new and wider bridge over I-10.

Frequently Asked Questions

WHEN WILL CONSTRUCTION START?

Construction is expected to start in March 2026.

WHAT CAN I EXPECT DURING CONSTRUCTION?

Construction activities may include pavement work, traffic shifts, and occasional nighttime closures. Please use caution when traveling through the interchange, as workers and heavy equipment will be present. Allow extra time to reach your destination, as delays may occur.

The project will improve circulation during high-demand hours along Mt. Vernon Avenue between East Valley Boulevard to the north and the I-10 eastbound ramps/Mt. Vernon Avenue intersection to the south.

Weekly construction alerts will be available to help you plan for detours or closures and provide details on when and where work will occur. As always, safety is our priority. To receive project updates and sign up for construction alerts, visit goSBCTA.com/i10mountvernon.

WHAT KIND OF ACCESS CAN I EXPECT DURING CONSTRUCTION?

Safety is our first priority. Local traffic may be routed to other access points. Signage and traffic alerts will be issued to advise you of these detours. Intermittent nighttime closures may be required during certain activities. Advanced notice of these detours will be posted on our website and sent out in our project construction alerts.

WHERE DOES THE FUNDING COME FROM TO BUILD THIS PROJECT?

The \$97.4 million project is funded through a combination of local funds including Measure I, and City of Colton Development Impact Fees (DIF). Measure I is a half-cent sales tax collected throughout San Bernardino County dedicated to transportation improvements.

We Plan.

The I-10/Mt. Vernon Avenue Interchange Project will replace the existing Mt. Vernon Avenue bridge over I-10 and provide local circulation improvements in the City of Colton. The interchange is a key connection for local and regional travel and currently experiences congestion and operational challenges. In addition, the intersection of Mt. Vernon Avenue and East Valley View Boulevard is a complex five-legged, signalized intersection that requires careful planning to support safe and efficient traffic operations. The project is designed to improve traffic flow, enhance safety, and prepare the corridor for future transportation improvements, including the planned I-10 Express Lanes.

We Build.

The Mt. Vernon Avenue bridge over I-10 will be replaced and lengthened to accommodate future I-10 Express Lanes and improve interchange operations. Construction will include bridge replacement, roadway and traffic improvements, and intersection modifications to enhance operations at Mt. Vernon Avenue and East Valley Boulevard. Activities may also include traffic shifts, intermittent lane closures, utility work, pavement work, and restriping. Workers and heavy equipment will be present in the project area, and drivers may experience temporary delays during construction.

You Move.

These improvements will reduce local traffic congestion, improve safety, and provide more reliable travel through the I-10/Mt. Vernon interchange. By enhancing local circulation and preparing for future Express Lanes, the project will support smoother, safer travel for drivers, commuters, and freight moving through the City of Colton and along the I-10 corridor.
