INTERSTATE 15 (I-15) NORTHBOUND TRUCK CLIMBING LANE EXTENSION

Overview

Interstate 15 (I-15) through the Cajon Pass is one of Southern California's most important transportation corridors. It connects the region to the rest of the country and supports daily commuting, regional travel, and the movement of goods.

The I-15 Northbound Truck Climbing Lane Extension Project will improve traffic flow and safety.

Proposed Project Improvements

- Extending the northbound truck climbing lane 3.4 miles, from north of Kenwood Avenue to State Route 138 (SR-138).
- Improving traffic flow by removing a lane drop.
- Improving traffic operations at the SR-138 interchange with new signals and queue management technology.
- Enhancing operations at the northbound CHP truck scales.

Project Benefits

- Improve safety by reducing merging and lane changes.
- Reduce traffic congestion and delays in the Cajon Pass.
- Enhance travel time reliability for both passenger vehicles and trucks.
- Support regional goods movement and economic activity.

Funding

The project is seeking funding through the California Trade Corridor Enhancement Program (TCEP). The estimated construction cost is approximately \$102 million. Final funding amounts and the project schedule are subject to funding approval.

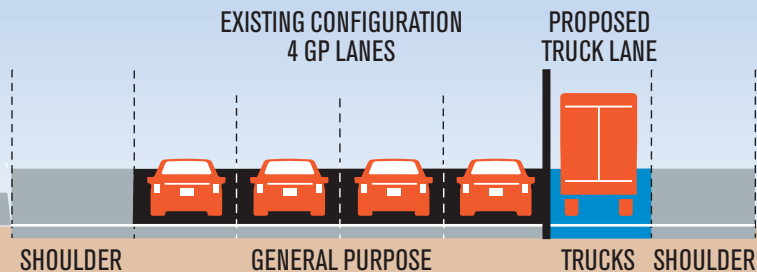
WHY IS PUBLIC INPUT IMPORTANT DURING THE PID PHASE?
